## **SRDC Celebrates 50 Years Serving the Region**

The Southwest Regional Development Commission celebrated its 50th Anniversary at the Annual Meeting at the Lower Sioux Indian Community on July 13, 2023.

**Regional Development** Commissions in Minnesota were formed under the auspices of the Minnesota Legislature as a result of the Regional Development Act of 1969. In order for a Commission to come into being under the act, local communities had to vote to ask the governor to form a Commission. On June 12, 1973, the elected officials and residents of Region 8 were informed by Governor Wendell Anderson that they had met

the required criteria and he was pleased to announce the formation of the Region 8 Development Commission.

The statutory purpose of the Commission as defined by the Regional Development Act is,

"to work with and on behalf of local units of government to develop plans or implement programs to address economic, social, physical, and governmental concerns".

The Board and Staff of the Southwest Regional Development Commission are pleased to be able to continue to serve the residents of the region as we begin our next 50 years.

# 2023 Project of the Year

At each year's Annual Meeting, the SRDC names a Project of the Year. This year's Project of the Year is the City of Tyler's Safe Routes to School Project.

In 2019, the City of Tyler faced a challenge. The RTR school district was planning a new school on the west side of town. This new location was in a field with no connecting sidewalks, near a railroad crossing; and it would attract more students because it was combining all the grades into one building. Community members wanted to make it safe for students to walk or bike to school. They organized and acted on their vision.

First, Tyler held a Walkable Community Workshop. Through a partnership between the Statewide Health Improvement Partnership (SHIP) and the Lincoln County Active Generations and with funds from MnDOT, they created goals and action steps to make Tyler a more walkable city. For their next step, they contacted the SRDC for assistance with writing a Safe Routes to School Planning Grant. Then, during the 2020-2021 school year, this group, along with the City of Tyler and the RTR school district, worked with SRDC to complete their plan.

Armed with a new plan, the City of Tyler applied to both a Safe Routes to School Infrastructure grant and a non-infrastructure "Boost Grant" to implement their top priority projects and goals. MnDOT funded both applications and Tyler received over \$500,000 to build sidewalks, purchase equipment and buy materials for education and engagement activities.

## **Revolving Loan Fund Update**

Currently, the SRDC has three separate loan funds available to help with your business, including two revolving loan funds and our Property Assessed Clean Energy or PACE program.

During the last fiscal year the SRDC closed on seven loans, spurring economic growth within the region. Loan recipients included restaurants such as Thee Old Bank in Tracy, Atlantic Place in Marshall, and Cabin Coffee in Jackson. In addition to the SRDC's revolving loan funds, SRDC staff also administers revolving loan funds for Jackson County, Heron Lake, and Falcon Development.

Total loans during FY 2023 were \$826,974.28

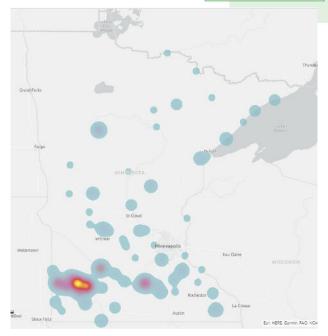

# **SRDC Completes Campground Surveys**

In the summer of 2022, SRDC staff conducted surveys on behalf of the Greater Minnesota Regional Parks and Trails Commission in seven regional parks. The parks surveyed included Garvin Park, Hole in the Mountain Park, Plum Creek Park, Ramsey Park and Twin Lakes Park in Region 8 as well as Lake Washington Park in Region 9 and Memorial Park in Region 6W.

The seven 2022 Campground User Surveys asked respondents to list their favorite campgrounds in Minnesota. Across all surveys, a total of 302 responses were provided. The heat map of favorite campgrounds (right) shows the locations of favorite campgrounds from all seven surveys. It is worth noting that across the board, the majority of respondents' favorites are located in southwestern and south central Minnesota. Many of these campgrounds can be seen as competitors to the seven regional campgrounds in southwestern Minnesota. Of the campgrounds listed, Garvin Park received the most "favorite" responses for regional campgrounds at 61 responses, followed by Plum Creek Park with 49 responses. Lake Washington Park received 22 responses, Hole in the Mountain Park 17 responses, Twin Lakes Park 15 responses, and Ramsey Park 13 responses. There were no responses mentioning Memorial Park. Top competitors to the seven regional parks were state parks, including Camden State Park (10 responses), Lake Shetek State Park (9), and

Itasca State Park (7). Thirty campgrounds in southwestern Minnesota were listed as favorites.

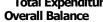

## **SRDC Supports Childcare Initiative**

There continues to be a strong link between childcare and economic development. A childcare shortage exists in this region, state, and beyond. Childcare is twofold in that it serves our current workforce, and prepares our future workforce. As a result of a request for proposal issued from the MN Department of Employment and Economic Development (DEED) at the beginning of SRDC's FY23, SRDC began providing technical assistance to the City of

Hills. SRDC staff worked alongside city staff as the application was developed, submitted, and later accepted. As a result of SRDC technical assistance, the City of Hills was successful in being awarded \$120,000 from DEED's Childcare **Economic Development** Grant Program to transform a main street tax forfeited blighted building, into individual spaces for three separate family childcare providers. This space has the capacity of serving 30 to 42 children at

completion. Stay tuned for an open house date that showcases how the City of Hills implemented an innovative and unique solution for the community to address their childcare shortage.
