Currie loop of Casey Jones revitalization

The Friends of the Casey Jones Trail group is hoping to secure enough support to restore other portions of the trail. They have requested \$3.15 million from the State to rehabilitate two segments of the Casey Jones State Trail – the Pipestone trailhead, along with three miles of the trail heading east of the Pipestone and the final segment (3rd phase) of the Currie Loop Trail.

The main issues with the existing Currie Loop section of the Casey Jones State Trail, which was built in the mid-90's, are that the asphalt surface has degraded to the point of being a rough surface with large cracks that make bike riding uncomfortable and the slope of the trail is not within ADA standards and therefore not considered handicap accessible. The trail reconstruction will address these issues plus install accessible bench rest stops and road crossings. The current phase (1st phase) of trail construction, approximately 2 miles, from the state park office to the intersection of County Road 38 and State Park Road, is due to be completed by June 30, 2024. The second phase of the project, which will rehabilitate the section of the trail adjacent to County Road 38 south to Currie, will be completed a year later.

## Hills Daycare Project









Hills recently completed a nearly three-year project renovating a dilapidated tax-forfeited building and turning it into a beautiful daycare project. According to Mayor Keith Elbers the city looked at various avenues for the building. Like many small communities, Hills had seen a drop in in-home childcare providers - losing at least six providers in the last 10 years.



With the help of grants and funding, the city turned a tax-forfeited property into three new spaces for independent childcare providers to use. Those providers only need to pay for utilities, allowing those who want to provide services the space to do so without having to use their own homes. All three spaces have providers occupying them with each having their own separate entrance.

Each space has its own kitchen and bathroom areas. A hallway connects to a large common play area. Additionally, once the weather warms, an additional play area will be created in an outdoor space.

Hills has become a model for other small communities facing similar situations. But like with any project, there were numerous roadblocks and setbacks throughout the process which is what Elbers hopes to help other communities avoid.

The SRDC assisted with grant writing, invoices, progress reports, and project coordination of the Hills Childcare Project. An Open House was held on Friday, January 19th which included a panel of speakers, tour, and lunch.


and the U of M campus in Morris, MN. This was a visit coordinated by Southwest RSDP (Regional Sustainable Development Partnership) staff, to help the World Mart food truck project gather ideas for their solar panel installation. Nathalie, World Mart's founder, was also able to make the trip to Morris for the tour. Planner Bucklin started the day at the WCROC facilities, with a tour of the grounds including the windmills, the renewable hydrogen and ammonia pilot plant, numerous solar panel arrays and solar thermal generation and storage, robotic vehicles for



agricultural use, and two solar trailers. The second part of the tour took place at the U of M Morris campus, with a look at a battery storage project, a biomass heating plant, and some of their green building projects such as building with insulated concrete foam. The solar trailers were a highlight for the World Mart project team, as they gave the team lots of ideas and information on how to install solar onto their own trailer. The WCROC and U of M Morris Campuses are truly inspiring when it comes to innovative sustainability and renewable energy projects.

#### **Solid Waste Regional Plan**

All counties in Minnesota must submit a solid waste plan to receive SCORE funds and apply for additional grants from the MPCA. Doing this as a 12-county Joint Powers Agreement decreases individual county costs, helps pull together resources, and arrange materials exchange for counties in the Southwest Minnesota Solid Waste Commission.



There are several issues and topics that will be addressed in the

plan. This includes support for 100% SCORE funding to counties for Solid Waste and Recycling activities, staff constraints on individual counties, Construction and Demolitions landfill capacity and the need for financial support from the state, and the education of the public and policymakers on the importance of sanitation services as a foundation for public health.

The Solid Waste Administrators met on January 19, 2024. SRDC Executive Director Trusty reviewed the current plan and facilitated a discussion that outlined the information each County Solid Waste Administrator will need to provide to write the plan. Despite the impending request to the MPCA to extend our current plan by two years, work will continue on the new plan. A draft plan is due to the MPCA by June 1, 2024.

## North Central Regional Food Business Center:

The SRDC continues to reach out and meet with various groups and individuals seeking ideas and suggestions. The Southwest Development Commission North Central RFBC (Regional Food Business Centers) Action Plan was developed and written to provide room for growth and enhancement over the next 5 years. Ideas and suggestions gathered through a comprehensive and inclusive approach include but are not limited to:

- Strengthening sustainability for local meat processors and small local grocery stores
- Increasing capabilities and efficiencies in providing meals to families
- Creating new markets to get local food to grocery stores, food shelves, and other institutions.
- Education for producers, sellers, and consumers
- Local commercial kitchen access for local producers
- Mobile meat processing
- Development of deep winter greenhouses for non-traditional producers
- Food delivery or transportation for residents to travel to local grocery stores, farmer's markets, and food shelves.

The Southwest Regional Development Commission is committed to working to boost Southwest Minnesota's food systems in response to supply chain weaknesses, small business challenges, and other difficulties exposed by the recent pandemic. The SRDC will begin publishing RFBC updates and opportunities via local newsletters (Farm Service Agency & Other Ag-related), the SRDC Website, and on social media.
